Road inspection report – Roads getting repaved are Velte – reclaimed and 2.5"pavement with 2' shoulder \$56,500; E. Hudson same as reclaimed 2.5" pavement, 2' shoulder \$60,400; W Hudson front end by Pond 200' or so \$35,150; Knitt Rd cross culver \$9500. Waupaca Cty look at Kratzke culverts, needs to be lifted up still need the quote from Greg? Reinke – cut sod on shoulders reclaim grade and compact \$11,500. Crack filling to bring others up to standard, Nick will look at those roads to see what needs to be done. Lynn will have Waupaca County proceed with repairs. Blacktop machine in Marion until end of June. Motion to repair the aforementioned roads roll call vote, passed Dave, Lynn, Pete.

Road Signs – Presentation from Rick Stuebs Waupaca County. 10-year life span. BCI (Brillo correctional institute) Simple Sign program – document every sign, work west to east, then south to north. Gps location of each sign. Document current sign and provide recommendation of DOT requirements. There is a time limit for requiring this be done, once started in the replacement program that will meet the time limit requirement. By having Waupaca County do it they are accepting Liability for correct installation. It will take 3 days to log and run signs \$3500 to be able to give pricing. Can have signs assessed and proposal by June meeting. Be able to give number of signs by type. Can include signs that are not currently in place. Project can be done over several years.
