Space needs assessment – Larrabee county shop. Facility has roof issues, no hvac system, single axle trucks. County has been buying Tri/Quad Axle Trucks. Larrabee shop too small for the larger trucks.

Bridge – Buckbee rd. 80/20 infrastructure money. Traffic, width, square footage to rebuild. Application due JUNE 1. Jared Seidel – DNR. Per Casey could cost the same to remove as to rebuild. Can stimulus money be used for infrastructure – per County – yes it can be used for that. Would like to see what the cost to replace is – 28ft wide is requirement (must meet DOT specs). . Free to apply, do not need to accept. Design date 1st yr, utility right-of-way 2nd yr. build 3rd year or later. Right of way requisition not included in funding. State takes control once we approve construction. State puts out the bids. Engineer estimate includes inflation. If project comes in above cost estimate no more from state. Casey will inflate estimate when applying. Must build in 5 years. Cost will most likely increase for lack of contractors. Casey will Call – when need to be on next agenda. Form is needed to be filled out for 50/50 bridge aid funds. Bridge estimate in next week or so. – per board okay to get the process started. Application by June 1st. Casey will help complete application and come back to get signature. STP Local bridge application.

County cannot perform federally funded jobs. Funding is meant to develop severely deteriorated roads.
